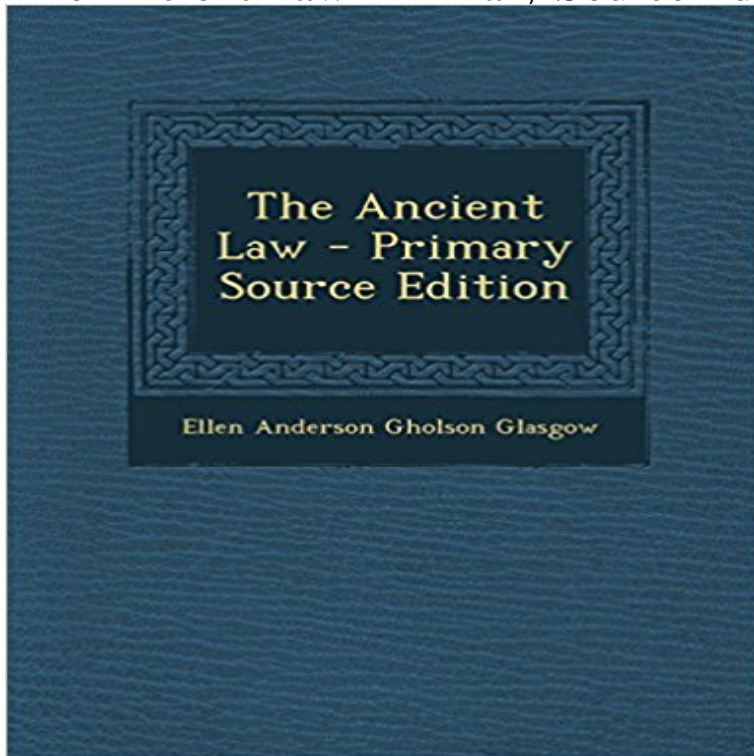


## The Ancient Law - Primary Source Edition
