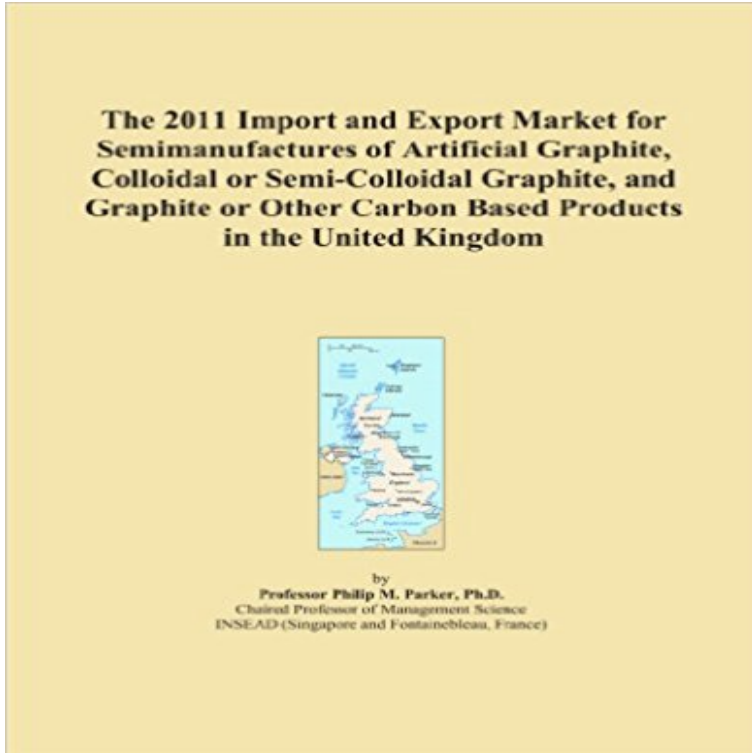


The 2011 Import and Export Market for Semimanufactures of Artificial Graphite, Colloidal or Semi-Colloidal Graphite, and Graphite or Other Carbon Based Products in the United Kingdom



On the demand side, exporters and strategic planners focusing on semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products in the United Kingdom face a number of questions. Which countries are supplying semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products to the United Kingdom? How important is the United Kingdom compared to others in terms of the entire global and regional market? How much do the imports of semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products vary from one country of origin to another in the United Kingdom? On the supply side, the United Kingdom also exports semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products. Which countries receive the most exports from the United Kingdom? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products in the United Kingdom. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for semimanufactures of artificial graphite, colloidal or semi-colloidal graphite, and graphite or other carbon based products for those countries serving the United

Kingdom via exports, or supplying from the United Kingdom via imports. It does so for the current year based on a
