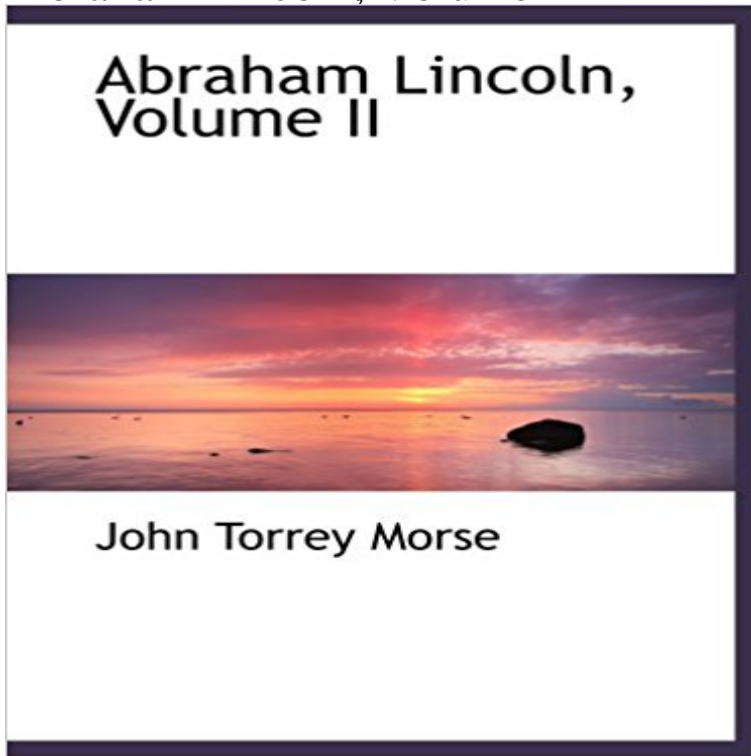


## Abraham Lincoln, Volume II
