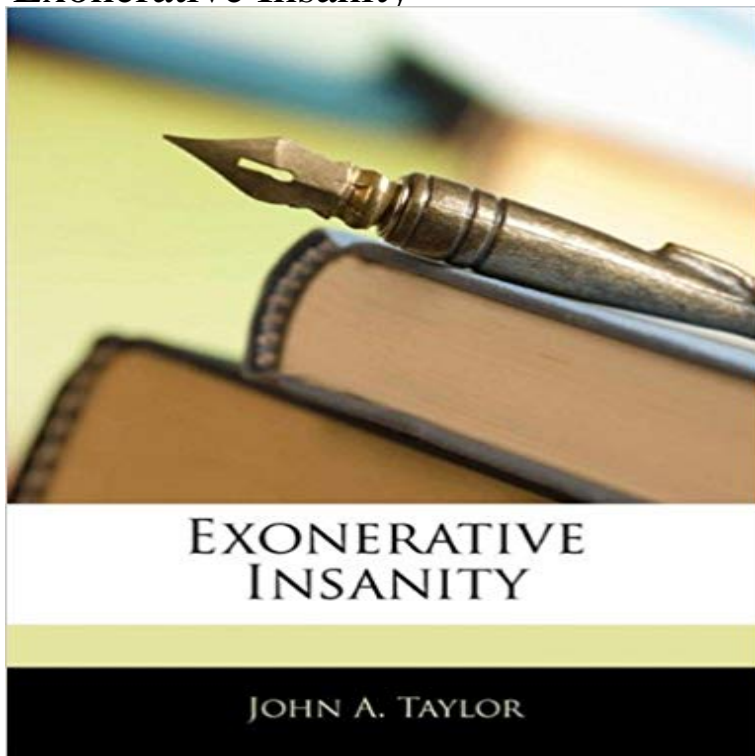


Exonerative Insanity
