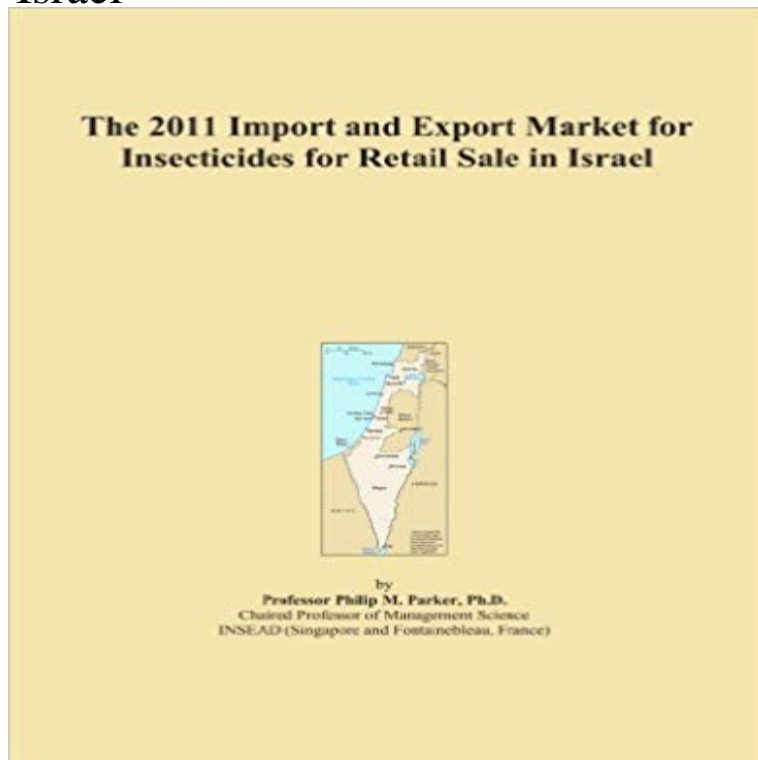


# The 2011 Import and Export Market for Insecticides for Retail Sale in Israel



On the demand side, exporters and strategic planners focusing on insecticides for retail sale in Israel face a number of questions. Which countries are supplying insecticides for retail sale to Israel? How important is Israel compared to others in terms of the entire global and regional market? How much do the imports of insecticides for retail sale vary from one country of origin to another in Israel? On the supply side, Israel also exports insecticides for retail sale. Which countries receive the most exports from Israel? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for insecticides for retail sale in Israel. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for insecticides for retail sale for those countries serving Israel via exports, or supplying from Israel via imports. It does so for the current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2 begins by summarizing where Israel fits into the world market for imported and exported insecticides for retail sale. The total level of imports and exports on a worldwide basis, and those for Israel in particular, is estimated using a model which aggregates across over 150 key country markets and projects these to the current year. From there, each country represents a percent of the world market. This market is served from a number of competitive countries of origin. Based on both demand- and supply-side dynamics, market shares by
