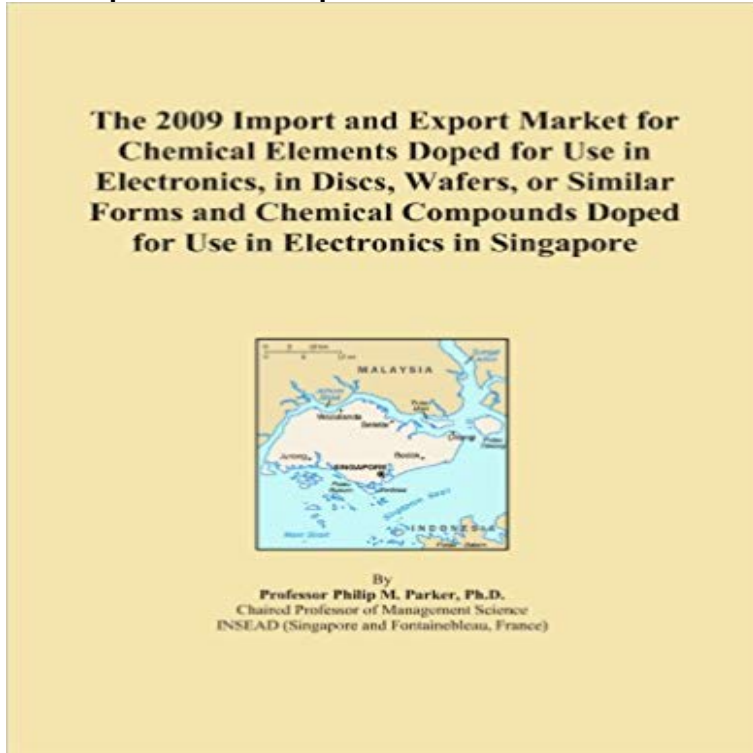


# The 2009 Import and Export Market for Chemical Elements Doped for Use in Electronics, in Discs, Wafers, or Similar Forms and Chemical Compounds Doped for Use in Electronics in Singapore

With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for chemical elements doped for use in electronics, in discs, wafers, or similar forms and chemical compounds doped for use in electronics for those countries

serving Singapore via exports, or supplying from Singapore via imports. It does so for the current year based on a variety of key
