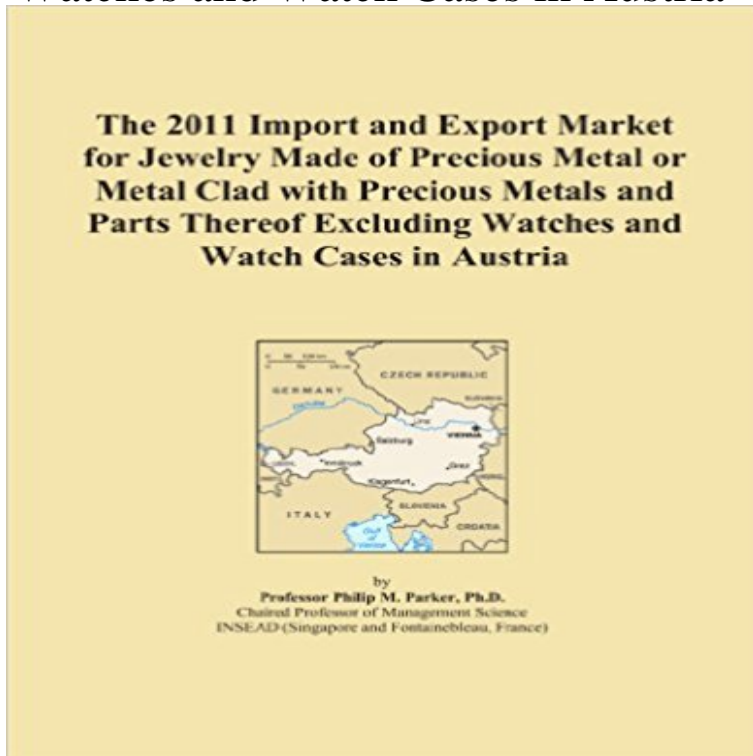


# The 2011 Import and Export Market for Jewelry Made of Precious Metal or Metal Clad with Precious Metals and Parts Thereof Excluding Watches and Watch Cases in Austria



On the demand side, exporters and strategic planners focusing on jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases in Austria face a number of questions. Which countries are supplying jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases to Austria? How important is Austria compared to others in terms of the entire global and regional market? How much do the imports of jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases vary from one country of origin to another in Austria? On the supply side, Austria also exports jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases. Which countries receive the most exports from Austria? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases in Austria. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for jewelry made of precious metal or metal clad with precious metals and parts thereof excluding watches and watch cases for those countries serving Austria via exports, or supplying from Austria via imports. It does so for the current year based on a variety of key historical indicators and econometric
