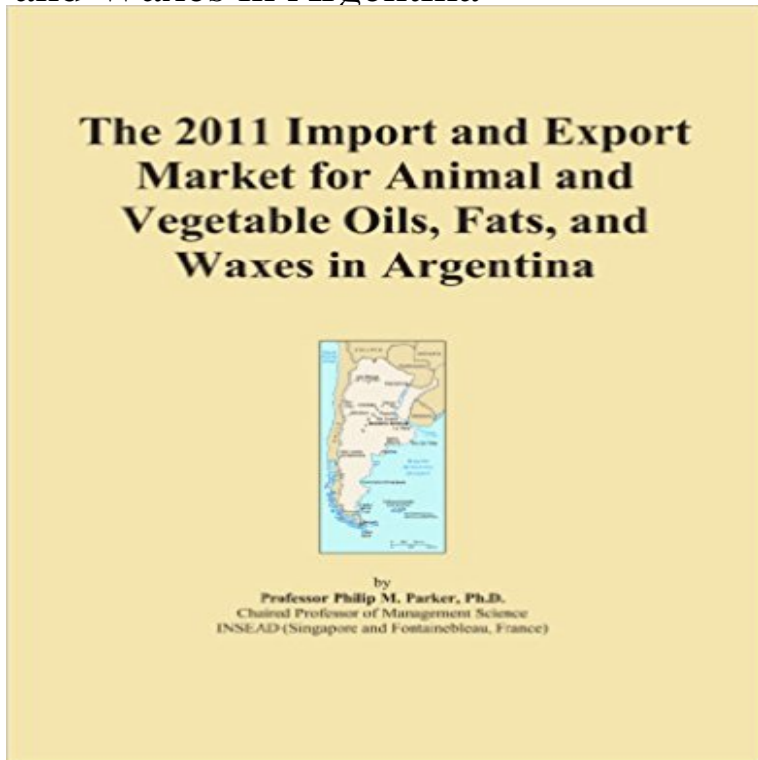


# The 2011 Import and Export Market for Animal and Vegetable Oils, Fats, and Waxes in Argentina



On the demand side, exporters and strategic planners focusing on animal and vegetable oils, fats, and waxes in Argentina face a number of questions. Which countries are supplying animal and vegetable oils, fats, and waxes to Argentina? How important is Argentina compared to others in terms of the entire global and regional market? How much do the imports of animal and vegetable oils, fats, and waxes vary from one country of origin to another in Argentina? On the supply side, Argentina also exports animal and vegetable oils, fats, and waxes. Which countries receive the most exports from Argentina? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for animal and vegetable oils, fats, and waxes in Argentina. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for animal and vegetable oils, fats, and waxes for those countries serving Argentina via exports, or supplying from Argentina via imports. It does so for the current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2 begins by summarizing where Argentina fits into the world market for imported and exported animal and vegetable oils, fats, and waxes. The total level of imports and exports on a worldwide basis, and those for Argentina in particular, is estimated using a model which aggregates across over 150 key country markets and projects these to the current year. From there, each country

represents a percent of the world market.
