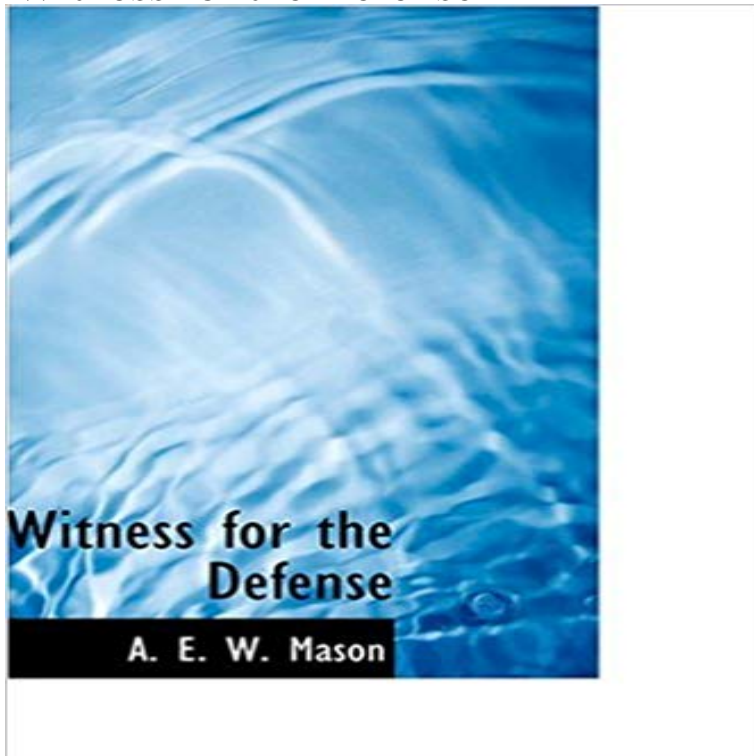


Witness for the Defense
